- Dogs must be one year of age or older on the day of Test
- Incomplete entries will not be accepted.
- Payment must be received with application for entry to be accepted
- Bitches in season and lame dogs will be excused and entries refunded.
- Refunds will be issued at no charge any time prior to March 20, 2024. You must call or email the secretary. There will be no refund after closing.
- Dogs may only run once per test.
- All AKC Rules regarding sportsmanship and conduct apply.

- The event-hosting club, its agents, members, representatives, volunteers, etc. assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property, and further assumes no responsibility for injury to children or spectators before, during or after the event.
- Persons exhibiting conduct detrimental to the AKC, Dog(s) or person(s) will be asked to leave the trial site by the Field Committee may be disciplined by the AKC, and entry fees will not be refunded.

Checking In

- Grounds will open at 7:45 a.m. and the event will begin at 8:00 a.m. Check in and inspection (Roll Call) will occur while in line for your run.
- These events will run CONCURRENTLY using a BLOCK schedule. NO RUN ORDER!
- Please check in no earlier than 15 min before your scheduled time block.
- Every entry will be inspected by the inspection committee before each run per event for lameness, fitness to compete and females in season.
- Dogs must be presented for inspection without tape, stitches, bandages, wrappings, or coverings (i.e. coat, blanket) of any kind.
- If in the opinion of the inspection committee any entry is found to be lame, unfit to compete or in season, that dog will not be allowed to run, and the applicable entry fee will be refunded.

Event Information

- TEST HOURS: Saturday 8:00 am-3:00 pm Eastern Time. Sunday 8:00 am-3:00 pm. Check-in closes at 1:30pm on BOTH days, you must have your first run checked in by 1:30 pm.
- Fast CAT will be divided into one-hour time blocks with concurrent tests. We will do our best to accommodate requests.
- Workers/volunteers may run their dogs prior to the first morning block, or their dogs may be added in during the day.
- Day of entries will be accepted if limits have not been reached. Day of entries should not arrive prior to 11:30 am to sign up. The Field Committee will determine if fun runs will be available. If so, they will start after the test has concluded each day and will start no later than 2:00pm as long as the test has closed.
- A gas / battery operated; continuous loop lure machine will be used. The lure will consist of plastic strips.
- An electronic break-the-beam timer will be used to record time.
- These events will be run concurrently. Dogs that have not yet run will have priority over dogs that will be running for the second test.
- Event staff may break periodically at the discretion of the Field Committee to

accommodate workers and allow for lunch.

- Professional photography is only allowed by the photographer hired by the CDTC. CDTC and the owner of the property are not and will not be involved in any disagreements between individuals and photographers. Competitors are allowed to photograph their own dog for their own personal use.
 - This is a rain-or-shine outdoor event. Please plan accordingly.
 - This is in the field on the PKC property. The entire property is fenced. In addition, temporary fencing will be used to mark the boundaries of the course.
 - Dogs are to be walked prior to running to warm them up and again after their run to cool them down.
 - Handlers should wear comfortable, sturdy shoes (no sandals or flip flops for safety reasons). Handlers should be physically able to hold and release their dogs or catch them.
 - Dogs must be on lead or crated unless running.
 - Children must be under control of their parent(s) or guardian(s) at all times. For safety reasons children under the age of 14 are not allowed to hold their dog on lead.
 - Please plan to bring your own shade and your own chairs
 - Lure coursing is a physically demanding sport so please make sure your dog is in good condition. If you are not sure, make an appointment with a veterinarian to get an opinion.

Running Your Dog

- You must bring or find a person at the test to release or catch your dog.
 CDTC is not required to provide assistance.
- Dogs will be brought to the start line on leash and released only upon a
 verbal signal ("Tally Ho") from the Huntmaster. It is recommended that dogs
 be handled with a "slip lead" that gives an instantaneous freedom to the dog
 when "Tallyho" (release) signal is called by the Huntmaster. Dogs may be
 released by hand, folded leash or using a traditional lure coursing slip lead.
- Dogs may run without a collar or wear any type of collar except choker collars, electronic training collars or head collar. Collars should be snug.
 Hanging tags pose a safety concern and it is suggested that tags be secured to the collar with tape. Dogs may run muzzled if desired. Clips or rubber bands may be used for long hair from falling across the dog's field of vision.
- Owners may use an elastic band to hold the dog's hair from their eyes.
- Owners assume all responsibility regarding the dog's collar and paraphernalia on the dog.
- Dogs may start up to 10 feet behind the start line.
- The run out will be at least 55 yards which exceeds the minimum of 30 yards required by the AKC.
- The owner or someone familiar with the dog should stand at the finish to catch the dog once the course has been completed.
- Handlers are not permitted to run with a dog during an official run. Handlers are not to entice the dog through the course with anything other than the

lure during its official run. NO mechanical devices including whistles, horns, bull horns, etc. Or toys including the waving of objects to lure the dog to the finish line. You MAY CHEER and use the dog's name.

Time

The FAST CAT is a timed straight race of 100 yards where a dog chases a lure. Dogs are run singularly and earn points based on their handicapped speed. The dog's time to complete the 100-yard dash is converted into MPH using the following formula:

MPH = 204.545 / (dog's time)

A handicap system is applied to a dog's MPH to determine the number of points earned. Points = MPH x dog's handicap. The handicap is based on the height of the dog at its withers:

- 18" or greater = handicap is 1.0
- 12" up to less than 18" = handicap is 1.5
- Below 12" = handicap is 2.0

Titles / Awards

Passing test scores will receive a light blue flat ribbon; Titles receive rosettes sponsored by Charlotte Dog Training Club

Titles are earned by accumulating points. The following titles will be awarded:

BCAT = 150 points

DCAT = 500 points

FCAT = 1,000 points

FCAT# = every additional 500 points (i.e. FCAT2=1,500 pts.)
