Conditions of Entry

- Dogs must have an AKC registration number, FSS number, PAL number or ILP number.
- Dogs must be one year of age or older on the day of Test
- Incomplete entries will not be accepted.
- Bitches in season and lame dogs will be excused and entries refunded.
- Dogs may only run once per test.
- All AKC Rules regarding sportsmanship and conduct apply.
- The event-hosting club, its agents, members, representatives, volunteers, etc. assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property, and further assumes no responsibility for injury to children or spectators before, during or after the event.

Checking In

- Check in and inspection will begin at 8:15 a.m. and the event will begin at 8:30 a.m.
- Every entry will be inspected by the inspection committee before each event for lameness, fitness to compete and females in season.
- Dogs must be presented for inspection without tape, bandages, wrappings, or coverings (i.e. coat, blanket) of any kind.

- If in the opinion of the inspection committee any entry is found to be lame, unfit to compete or in season, that dog will not be allowed to run, and the applicable entry fee will be refunded.

Event Information

- Health and safety measures will be in place with regards to the current pandemic situation. All participants will be asked to sign the enclosed COVID-19 waiver.
- The property owners have required clubs hosting events to follow North Carolina [Executive Order 147](#), participants & spectators must wear cloth masks over their nose & mouth on PKC property where physical distancing is not possible and inside the building. - Due to Covid-19 restrictions block times/running orders may apply. Participants will be notified if block time applies after early entries close.
- Day of entries will be accepted if limits have not been reached. Day of entries should not arrive prior to 10:00 a.m.
- A gas / battery operated; continuous loop lure machine will be used. The lure will consist of plastic strips.
- An electronic break-the-beam timer will be used to record time.
- These events will be run concurrently. Dogs that have not yet run will have priority over dogs that will be running for the second test.
- Event staff may break periodically at the discretion of the Field Committee to accommodate workers and allow for lunch.
- Professional photography is only allowed by the photographer hired by the CDTC. CDTC and the owner of the property are not and will not be involved in any disagreements between individuals and photographers. Competitors are allowed to photograph their own dog for their own personal use.
- This is a rain-or-shine outdoor event. Please plan accordingly.
- This is in the field on the PKC property. **The entire property is fenced.** In addition, temporary fencing will be used to mark the boundaries of the course.
- Dogs are to be walked prior to running to warm them up and again after their run to cool them down.
- Handlers should wear comfortable, sturdy shoes (no sandals or flip flops for safety reasons). Handlers should be physically able to hold and release their dogs or catch them.
- Handlers may carry toys or treats on their persons to assist with retrieving their dogs at the completion of their run.
- Dogs must be on lead or crated unless running.
- Children must be under control of their parent(s) or guardian(s) at all times. For safety reasons children under the age of 14 are not allowed to hold their dog on lead.
- Please plan to bring your own shade and your own chairs
- Lure coursing is a physically demanding sport so please make sure

your dog is in good condition. If you are not sure, make an appointment with a veterinarian to get an opinion.

Running Your Dog

- **You must bring a person to release or catch your dog.** Event staff will not be able to release or catch dogs that they do not personally know.
- Dogs will be brought to the start line on leash and released only upon a verbal signal (“Tally Ho”) from the Huntmaster. It is recommended that dogs be handled with a “slip lead” that gives an instantaneous freedom to the dog when “Tallyho” (release) signal is called by the Huntmaster. Dogs may be released by hand, folded leash or using a traditional lure coursing slip lead.
- Dogs may run with or without a collar for safety reasons. Unacceptable collars are martingale, choker collar, prong collar, or electronic collar. Tags, bandanas or other similar items are not allowed for safety reasons.
- Owners may use an elastic band to hold the dog’s hair from their eyes.
- Owners assume all responsibility regarding the dog’s collar and paraphernalia on the dog.
- Dogs may start up to 10 feet behind the start line.
- There will be a safe run-out area that is a minimum of 30 yards. The owner or someone familiar with the dog should stand at the finish to catch the dog once the course has been completed.

Time

The FAST CAT is a timed straight race of 100 yards where a dog chases a lure. Dogs are run singularly and earn points based on their handicapped speed. The dog’s time to complete the 100-yard dash is converted into MPH using the following formula:

$$\text{MPH} = 204.545 / (\text{dog's time})$$

A handicap system is applied to a dog’s MPH to determine the number of points earned. Points = MPH x dog’s handicap. The handicap is based on the height of the dog at its withers:

- 18” or greater = handicap is 1.0
- 12” up to less than 18” = handicap is 1.5
- Below 12” = handicap is 2.0

Titles / Awards

Passing test scores will receive a light blue flat ribbon; Titles receive rosettes sponsored by Charlotte Dog Training Club

Titles are earned by accumulating points. The following titles will be awarded:

BCAT = 150 points

DCAT = 500 points

FCAT = 1,000 points

FCAT# = every additional 500 points (i.e. FCAT2=1,500 pts.)
